## CALL FOR ENTRIES

The fourth biennial ARTSfest will again host thousands of visitors to charming Grace Court in the heart of Winston-Salem's first "Streetcar Suburb." ARTSfest 2009 will consist of a juried group of artists selling original fine art & fine crafts accompanied by outstanding musical entertainment. Area restaurant vendors will provide "taste of West End" and beyond.

Artists invited to show their work are chosen by an independent jury from the regional visual arts community. Each entry receives a numerical score from each juror and the highest scores within each medium category are selected. Judging for festival awards will be on September 26, 2009 from 9 am - 11 am. Awards will be announced at ARTSfest.

#### Prizes:

Best in Show: \$500 (*non-category specific*)  
4 Juror's Choice: \$100 each (*1 per category*)  
4 Merit Awards: \$50 each  
Cover Award  
(To be selected in June)

#### Jury Deadline:

**All components of the entry, including entry fee, must be received by ARTSfest 2009 by 5pm June 1, 2009 for consideration. Entries will not be accepted after the deadline.**

Jury Notification is June 30

Artist info packets & postcards will be available for pick up on September 1<sup>st</sup>.

ARTSfest 2009: September 26 from 10am to 5pm

Artist check in and setup: 7am to 9am

Tear down and cleanup: 5pm to 6pm

Party: 6pm to 9pm (open to all artists, sponsors, volunteers & spouses)

#### Entry Guidelines:

1. All work displayed must be the artist's own work and must be for sale.
2. ARTSfest reserves the right to exclude displays that have been misrepresented by the artist's digital images or application.
3. Spaces must be attended by the artist during the festival.

#### Art not eligible:

1. Art reproduced from works of any artist other than the applicant.
2. Commercially produced merchandise.
3. Clothing and accessories that are not hand-crafted.
4. Dried flowers, soap, or candles.

#### Sales tax:

ARTSfest receives no commission on sales. Each artist is responsible for the collection of North Carolina sales tax.

**IMPORTANT!: Your entry indicates agreement to comply with all terms and conditions.**

1. Applicant does hereby release and hold harmless West End Association and the city of Winston-Salem of and from all manner of actions, suits, damages, claims from any loss or damage to property of artist.
2. Applicant consents to all festival terms.
3. Applicant gives permission for photos of work accepted to be used for festival promotion.
4. There is no rain date for the 2009 event. The show will go rain or shine so be prepared. In the event of severe weather causing a cancellation, there will be no refunds for entry fees.

**SELECTION PROCESS BY JURY:**

The ARTSfest 2009 juried art show will be selected by digital image only via email submission. The jurors reserve the right to refuse any art not conforming to entry representation. The ARTSfest 2009 committee reserves the right to refuse any art not conforming to entry specifications as stated below. Artists must submit a total of 5 works to be presented at ARTSfest 2009; 4 images of works to be entered; 1 image of the artist's presentation booth. Send one view of each 2 dimensional work. Up to 3 views may be sent for each sculpture.

**SUBMITTING DIGITAL IMAGES:**

Please be sure that your images follow the stated guidelines before sending. Improperly submitted images will not be accepted for the jury process.

Send only JPEGs with .jpg extension, no more than 800 pixels in the long dimension at a browser resolution of 72 dpi.

Each image must be named as follows: your last name, first and middle initials and entry number (1 – 5). Jane S. Smith's first entry would be SmithJS1.jpg. For multiple views of a single 3 dimensional work add a, b or c. (SmithJS1a.jpg.) Use letters and numbers *only*, with no special characters or spaces.

**EMAIL** images as individual attachments to a single email. Put **ARTSfest 2009** in the Subject line and put your full name, address, phone number and a numbered inventory with title, medium and price in the body of the email as indicated in the examples below:

Image 1- Still of Night	oil on canvas	\$700	
Image 2- Reflections	watercolor on paper	\$250	
Image 3- Untitled	Raku Pottery Vase	\$125	Etc.
